STEP 1	APPLICATION EVALUATION & VERIFICATION	Person Responsible: BPLO Processing Time: 5-10 minutes
STEP 2	ASSESSMENT & PAYMENT OF FEES AND TAXES	Person Responsible: BPLO/ Municipal Treasury Processing Time: 10-20 mins.
STEP 3	ISSUANCE OF PERMIT	Person Responsible: BPLO Processing Time: 5-15 minutes

INCENTIVES

FISCAL INCENTIVES:

Discount from the payment of business tax for a specified number of years depending on capital investment from the date of approval of registration by the Allacapan Local Investments and Incentives Board

NON-FISCAL INCENTIVES

1. One stop documentary registration procedure assistance
2. Assistance in site selection and negotiation of special rates for utilities for industries with a certain minimum load
3. Assistance in labor recruitment
4. Assistance in resolving issues and concerns with service providers
5. And other non-fiscal incentives as maybe determined by the Board
